Porter is our present family genealogist and does excellent work. She not only includes a reference to where she found the information, but also copies the information and includes it in the notes section. The New England Genealogical Society has asked her permission to use some of her research material on the Elizabeth Porter line to show how to verify and document instances where few or no records are available. They stated that Janet's documentation is some of the finest they have ever

Janet has spent an enormous amount of her own money to do the research. We have helped her some, but the organizations funds have not been sufficient to do what we need to do. Particularly as we need to reach out into areas that will require more travel to find the needed information. How did the notion of a Bear Lake monster originate? There is one source found in the PWC bookstore. It is contained in a Cook Family Ancestral Guide for Utah. Here is a snippet:

"The 'Bear Lake Monster' had come up again. Marion Thomas and three sons of Phineas were on the lake fishing, opposite Swan Creek, and came near his majesty. Brother Thomas describes its head as serpent-shaped. He saw about twenty feet of its body, which was covered with hair or fur, something like an otter and light brown. It had two flippers, extending from the upper part of the body which he com-

pared to the blades of his oars. He was so near it that if he had had a rifle he could have shot it." +
