

PRESIDENT'S MESSAGE

After 7 years of effort, LaMar Day can point with pride to the completion of a video version of slides about P.W. Cook, his wives and children.

Members of the board viewed the video at their May meeting and were well pleased with it. It is not quite up to overall quality of the PBS documentary on the Civil War, but it didn't cost millions of dollars either, and my interest in these people lead me to be nearly as as fascinated by this 40 minute video as I was by the PBS documentary. I don't want to oversell the video; it has its limitations. But I think it is an excellent effort and well worth obtaining.

The organization will recover the production costs after about 70 copies have been sold. We have some orders I think the video is already. an excellent way to interest children in their ancestors. This may be the way family history records will be preserved and presented in the 21st century.

I encourage you to obtain a copy of the video. I plan to.

GENEALOGY NEWS

We have a new person in charge of the Genealogical Research Committee: Janet Porter. Her address and phone number are: 430 South 450 East Orem Utah 84058, 801-226-8094.

Janet is the mother of 10 children, with two in college and two on LDS missions. She is very busy, but wants to help and is very enthusiastic about accepting the responsibility for genealogical research for the organization. We're fortunate to have her with us, and I'm sure she will do an outstanding job.

A lot of family members are doing research, but we fear that many are repeating once again what has been done many times before. We want to minimize duplication of effort and spent time plowing new ground.

We would like to provide each individual who desires to do research with a packet of materials that would include:

A copy of work already verified by us. A copy of work done on an assigned line. An assignment to do research on particular lines -- individuals can ask for a line they want to work on.

Several could be working on the same line and as new information is obtained, it would be sent to Janet who will enter it into the research data base and see that it is shared with those working on the line.

We will also maintain a separate data file of verified records. Before the newly researched information is entered into the verified files, the information will be carefully reviewed by the Verification Committee to assure the accuracy and reliability of the work. No researcher should feel concern about this, since once the verification is completed the Family Organization will recognize the work and stand behind it. The organization is registered with the Family History Library in Salt Lake. They value what we are doing.

This approach to organized family research is a combination of the best approaches we have seen. It is good in theory and should assist the family in getting the research done. To be successful, we have to have a lot of help. We need to be able to count on YOU. Please let us know if you can help.

Lots of people desiring to do research. A few in the Salt Lake area to serve on the Verification Committee.

We are excited about the great opportunities ahead and grateful that Janet Porter is willing to coordinate the effort.

SWEDISH RESEARCH

I met with Steve Parkes a few weeks ago to discuss the research situation on Johanna Christina Polson's lines. I learned that his employment situation is forcing him to give up active genealogical research. He will provide the names of some other accredited Swedish genealogists to carry on the effort.

From our discussion, I learned the following points:

1. The work initiated decades ago by Carl Cook and carried out by Swedish professionals seems to hold up well to modern scrutiny. No important errors have been discovered so far.

2. Many of the lines are back to the beginning of parish registers or other sources. When the records run out, work on direct lines becomes impossible. Collateral lines are always possible, however. 3. Some of that work may well best be done through name extraction efforts, although the task of linking up families will not be accomplished through name extraction.

4. Steve found that his lines and ours run together at a certain point. That made him doubly interested in our research, but as already indicated, he cannot presently spare the time to do genealogy and wishes to relinquish the account.

We have the financial resources to carry out more research, but the Polson branch needs to decide what it wants to do.
